Congratulations on your new tires! The Limited Road Hazard Plan ("Plan") covers the passenger or light truck tires you purchased from road hazard damage. The Plan is valid for a period of one (1) year from the date of purchase or until any portion of the tire treadwear is worn 2/32 of an inch or less, whichever occurs first.

Tire replacement up to 100% of the original retail price paid if the road hazard damage cannot be safely repaired per manufacturer's guidelines

Up to \$25.00 to cover tire repairs due to road hazard damage

Honored nationwide

Tires not able to be safely repaired will be replaced with the same tire as originally equipped, or a comparable tire up to 100% of the retail price paid for the original tire, as stated on the original retail sales invoice. You will be responsible for any taxes, mounting, balancing, and any other miscellaneous fees.

If possible, you should return to the selling dealer where you originally purchased your tires for tire repair or replacement service. If you are away from the original selling dealer, you must contact the Program Administrator by calling 844-427-0843 for assistance in locating the nearest participating facility. You must present the original invoice showing the purchase of the tires. The damaged tire must be made available for inspection by the facility and/or the Program Administrator. All claims and any required documentation must be submitted to the Program Administrator within 60 days of the date of failure and/or service for reimbursement. This Plan does not have a deductible.

You may opt out of the benefits provided to you under this Plan by contacting the Program Administrator. This Plan is offered to you as a benefit at no additional cost with the purchase of eligible tire(s); therefore, this Plan is non-cancellable. You are not entitled to any credit, refund or remuneration should you opt out of this Plan.

This road hazard program, or any warranty stated or referred to herein, is exclusive and in lieu of any other warranty regarding the quality of API tires, whether expressed or implied, and remedies for breach thereof shall be limited to those specifically provided herein.

LIMITED WARRANTIES:

LIMITED WARRANTY ON SPECIFIC X COMP TIRES

No tire manufacturer or dealer can assure that you will achieve a certain number of driven miles or months of use from a given tire because driving habits, road & driving conditions, & vehicle maintenance & condition all play a role in tire tread life & all differ with each purchaser. However, the X Comp tire lines listed in the Tread Life Warranty Table at the end of this Limited Warranty are warranted for a specified number of actual miles driven or months of installation ("Tread Life") on the original vehicle, whichever first occurs. The X Comp tire lines not specifically identified in the Tread Life Warranty Table are not covered by a Tread Life Limited Warranty & are only warranted against defects in material & workmanship.

If you purchased an X Comp tire identified in one of the Tread Life Warranty Tables & the tire wears evenly, but fails to provide the number of warranted miles of use, you are entitled to receive a prorated allowance applicable to the purchase price of a comparable new replacement X Comp tire or another brand of tire offered by API Brands. The amount of the warranty replacement allowance is based on the "Usable Tread Life" of each warranted X Comp tire line. The amount of the allowance will be equal to the percentage of the warranted Usable Tread Life remaining (miles) when the end of tire's Usable Tread Life has been reached.

A tire's "Usable Tread Life" is the original tread groove depth down to the treadwear safety indicator bars that are molded into the tire groove. The treadwear indicators are reached when only 2/32nds of an inch of tire tread remains. A tire has delivered its full "Usable Tread Life" when its original new tire tread has become worn down to the treadwear indicators at 2/32" (1.6 millimeters) of tread remaining. Tires become unsafe for use & must be replaced to avoid accident or injury when the tread depth remaining is 2/32" or less. The Limited Tread Life Warranty does not cover & you are responsible for the charges for mounting & balancing the replacement tire, & applicable taxes.

100% FREE REPLACEMENT WARRANTY

American Pacific Industries, Inc (API) hereby warrants every new Gladiator Light Truck (LT) tire for workmanship and material related conditions for the life of the original tread of a new tire less 2/32". The life of the original usable tread ends when the tire tread has worn down with only 2/32" remaining as measured in the fastest wearing groove, at which point the tire is considered to be fully worn out. API will refund the cost of a replacement Gladiator LT tire. Applicable taxes on the new tire and costs of mounting and balancing service shall be borne by the owner. All Exclusions listed below void this 100% Free Replacement Warranty. Conditions and coverage are subject to change at any time and without notice

- A) The Gladiator LT tire must be replaced with a comparable new Gladiator LT tire by an authorized Gladiator dealer. Copy of invoice will be required.
- B) 100% free replacement applies to new first quality tires. Blemished tires, retreads and road hazard tires are specifically excluded (see Road Hazard Warranty below),
- C) Adjustments on ride complaints or out of round tires are excluded from this warranty if they are worn past 2/32" from the original usable tread of the new tire.

SATISFACTION ASSURED

All API passenger and LT tires are covered by the 30 Day "Satisfaction Assured" trial period. If, for any reason, other than an excluded condition listed in the respective tire's Standard Warranty, you are not satisfied with your new set of tires within 30 days of date of purchase - or the first 2/32nds of tread wear as measured in the fastest wearing groove (whichever comes first) - you may exchange all or any one of them for the same number of the same design or similar design API manufactured tires. Mounting and balancing are free of charge (excluding online orders). Owner pays all applicable taxes. If you wish to exchange for another set of API manufactured tires that have a higher cost, you must pay the upgrade from the original purchase price, including shipping and all applicable taxes. If you wish to exchange for another set of tires, which is at a lower cost, you will receive a credit for the difference in cost. This Satisfaction Assurance guarantee only applies to the original new set of manufactured passenger and LT tires purchased and not to the replacement tires under this guarantee.

Administration of the Assured Satisfaction Warranty - Within the 30 days from the date of purchase or the first 2/32nds tread wear as measured in the fastest wearing groove, you must return your tires to the authorized API brand tire dealer where you purchased your tires. You must present the original sales receipt and proof-of-purchase. Reason for dissatisfaction must be explained to the dealer (i.e., appearance, ride, handling, etc.) and noted on the adjustment claim form.

EXCLUSIONS

- A) All Gladiator warranties are limited to the original purchaser and the original vehicle on which they are mounted, and are not assignable to subsequent purchasers or vehicles.
- B) The warranties listed above are applicable only in the United States and Canada and any tire used or equipped on a vehicle registered or operated outside the United States and Canada are not covered by these warranties.
- C) The following is not covered by the warranties listed above:
 - 1) Tire branded or marked "Non-Adjustable" (N/A) or "Blemished" (Blem), or previously adjusted.
 - 2) Failure, damage or irregular wear due to: a) fire, accident or vandalism; b) mechanical condition of vehicle, including improper alignment, improper inflation, wheel imbalance, faulty shocks or brakes; c) misapplication of tire; or d) alteration of the tire, addition of foreign material, transfers from one vehicle to another or any previous damages and/or repairs.
 - 3) Cost of mounting and balance service.
 - 4) Loss of time or use, inconvenience, or any incidental or consequential damages except as prohibited by law.
 - 5) Adjustment on out-of-balance or out-of-round tire is allowed only during the first 2/32" of the original tread as measured in the fastest wearing groove. A set of all four (4) tires from the same vehicle claimed for out-of-round will not be accepted.
- D) Any Gladiator LT tire produced five (5) years from date of manufacture as determined by the DOT/Serial number are not covered under the warranties listed above.

REPAIRS AND RETREADING: RATING CHANGES AND CAUTION

- A) Repaired, retreaded or altered Gladiator tire with "Speed Rating(s)" no longer retain their "Speed Rating".
- B) If the aforementioned tire(s) is repairable, see the recommended repair procedures used by the tire dealer(s) for repairing tubeless passenger car radial tires as detailed and illustrated in the RMA puncture repair procedures.
- C) Repairs must be restricted to the tread area inside a half inch of the sidewall of the tire.
- D) Do not repair any punctures that are larger than 1/4" in diameter.

OWNER'S OBLIGATIONS

In order to be eligible for Gladiator LT Limited Warranty service, the dealer/owner must:

- A) At the time of purchase, the tires must be properly installed, correct air pressure set and the wheels balanced. Every 6,000 miles the tires must be rotated, proper air pressures set and the wheel alignment checked.
- B) Any tire to be adjusted must be presented to an authorized Gladiator dealer.
- C) Present proof of purchase to the satisfaction of the dealer.
- D) Complete and sign a Gladiator Warranty Claim Form which is available at any authorized dealer.
